If you return this proxy form without indicating as to how your proxy is to vote on any particular matter, the person appointed as your proxy will exercise his/her discretion as to whether he/she votes and, if so, how and, unless instructed otherwise, he/she may also vote or abstain from voting as he/she thinks fit on any other business (including amendments to resolution) which may properly come before the 2025 First H Shareholders Class Meeting. The shares abstained will be counted in the calculation of the required majority.
- 7. This proxy form must be signed and dated by the shareholder or his/her attorney duly authorized in writing. If the shareholder is a company, it should execute this proxy form under its common seal or by the signature(s) of its legal representative(s) or its directors or (a) person(s) authorized to sign on its behalf. In case of joint holders, only the person whose name stands first on the register of members may attend and vote at the 2025 First H Shareholders Class Meeting, either in person or by proxy.

To be valid, this proxy form, together with the power of attorney or other authorization documents, if any, under which it is signed, or a notary certified copy of such power of attorney or authorization documents, must be completed and deposited at the office of the H share registrar of the Bank in Hong Kong, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong at least 24 hours before the 2025 First H Shareholders Class Meeting (i.e. not later than 9:30 a.m. on Monday, 24 March 2025).
- 9. Completion and delivery of this proxy form will not preclude you from attending and voting at the 2025 First H Shareholders Class Meeting in person if you so wish.
- 10. Shareholders or their proxies attending the 2025 First H Shareholders Class Meeting shall produce their identity documents.
